PROCUREMENT OF VEHICLE HIRE SERVICES

RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF VEHICLE HIRE SERVICES for CY 2020 REQUIREMENTS

WHEREAS, Open Competitive Bidding for the Procurement of Vehicle Hire Services for CY 2020 requirements was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

WHEREAS, on December 05, 2019, the Invitation to Bid (IB) was posted in the PhilGEPS;

WHEREAS, a Pre-bidding Conference was held on December 13, 2019 at 10:00 am at DOH-CAR Office Regional Training Center, BGHMC Compound, Baguio City where four (4) prospective bidders attended, namely:

1. Ms. Pauline G. Botelas – Cobelliam Corp
2. Mr. Crisostomo Yatar Sr. & Ms. Marnelle Dulnuan – JBMTSC
3. Mr. Terence Caput – Renztyryde Transport
4. Mr. Cliff Saitin – Polisville Car Rental

WHEREAS, the Submission and Opening of Bids took place as scheduled on December 27, 2019 at 1:30 pm at the Regional Training Center, Department of the Health-Center for Health Development-Cordillera Administrative Region (DOH-CHD-CAR) Office, BGHMC Compound, Baguio City;

WHEREAS, four (4) prospective bidders procured the bidding documents and submitted their respective proposal, namely:

1. Smokey Transport Inc.
2. Join Baguio Movement Tourist Service Cooperative (JBMTSC)
3. Renztyryde Transport
4. Cobelliam Corporation

WHEREAS, the first envelopes containing the Eligibility and Technical Documents were opened. The presence, completeness and correctness of the required documents were checked and verified by the RBAC in the presence of the prospective bidders' representative. Upon checking, Join Baguio Movement Tourist Service Cooperative and Renztyryde Transport were declared "NOT ELIGIBLE" and were rated "FAILED" because of improper sealing and markings, while Smokey Transport Inc. and Cobelliam Corporation were declared "ELIGIBLE" and were rated "PASSED";

WHEREAS, the second envelopes containing the Financial Proposals were opened. The presence, completeness and correctness of the required documents were checked and verified by the RBAC. Upon checking, Smokey Transport Inc. and Cobelliam Corporation were declared "ELIGIBLE", were rated "PASSED" and subsequently the bid proposals were read publicly and written in the Abstract of Bids, to wit:

WHEREAS, the bids listed below were found to be substantially complying;

WHEREAS, Join Baguio Movement Tourist Service Cooperative and Renztyryde Transport submitted their Motion for Reconsideration dated December 27, 2019 because of improper sealing and markings. A reply letter dated January 3, 2020 was sent to the bidders denying their motion.

WHEREAS, letter dated December 28, 2019 was sent to the Lowest Calculated Bidder (LCB), Smokey Transport Inc., requesting to submit post qualification requirements;

WHEREAS, on January 6, 2020, Smokey Transport Inc. submitted their respective additional documentary requirements as part of their technical requirements;

WHEREAS, on December 27, 2019 to January 6, 2020, detailed evaluation of the submitted proposal on the Legal, Technical and Financial aspects of documents on the Lowest Calculated Bidder (LCB) for the above items was undertaken by the designated Technical Working Group (TWG);

WHEREAS, on January 8, 2020, the TWG submitted their Bid Evaluation and Post Qualification Reports citing specific findings on the submitted documents/clarifications by the LCB for each item;

WHEREAS, a letter dated January 9, 2020 was received from Join Baguio Movement Tourist Service Cooperative commenting on the bids submitted by Smokey Transport Inc. and Cobelliam Corporation regarding valid authority to operate as public transport or franchise from LTRFB;

WHEREAS, a reply letter dated January 15, 2020 was sent to Join Baguio Movement Tourist Service Cooperative informing them that the winning bidder, Smokey Transport Inc., submitted their authority to operate as public transport during the bid opening;

WHEREAS, on January 22, 2020, the TWG presented to the BAC their Bid Evaluation and Post Qualification Reports citing specific findings on the submitted documents/clarifications by the LCB for each item;

WHEREAS, the Bids and Awards Committee (BAC) certifies that there is “no pending incident” as regard to the result of the post qualification evaluation for this particular project;

NOW THEREFORE, on the basis of the above, the herein members of the BAC HEREBY RESOLVE, to award the Procurement of Vehicle Hire Services to the following bidder that was determined to have the Lowest Calculated and Responsive Bid (LCRB):

- 1. Smokey Transport Inc. with a Total Contract Price of One Million Eight Hundred Three Thousand Five Hundred Pesos only (₱ 1,803,500.00) inclusive of local taxes for the item/project listed below:**
