Package I - PROCUREMENT OF DRUGS AND MEDICINES

RECOMMENDING THE AWARD OF CONTRACT FOR PACKAGE I specifically Item No. 5, and, DECLARING FAILURE OF BIDDING for Item Nos. 1, 2, 3, 4, 6, 7 & 8 FOR THE PROCUREMENT DRUGS and MEDICINES for CY 2020 REQUIREMENTS

WHEREAS, Open Competitive Bidding for the Procurement of Drugs and Medicines for CY 2020 requirements was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

WHEREAS, on April 22, 2020, the Invitation to Bid (IB) was posted in the PhilGEPS and DOH Website;

WHEREAS, a Pre-bidding Conference was held on April 30, 2020 at 10:00 am at DOH-CAR Office Regional Training Center, BGHMC Compound, Baguio City no prospective bidder/s attended;

WHEREAS, the Submission and Opening of Bids took place as scheduled on May 12, 2020 at 10:00 am at the Regional Training Center, Department of the Health-Center for Health Development-Cordillera Administrative Region (DOH-CHD-CAR) Office, BGHMC Compound, Baguio City;

WHEREAS, one (1) prospective bidder, Metro Drug, Inc., procured the bidding documents and submitted their respective proposal;

WHEREAS, the first envelope containing the Eligibility and Technical Documents was opened. The presence, completeness and correctness of the required documents was checked and verified by the designated Bids and Awards Committee (BAC). Upon checking, Metro Drug, Inc. was declared "ELIGIBLE" and was rated "PASSED";

WHEREAS, the second envelope containing the Financial Proposal was opened. The presence, completeness and correctness of the required documents were checked and verified by the BAC. Upon checking, Metro Drug, Inc. was declared "ELIGIBLE", was rated "PASSED" and subsequently the bid proposal was read publicly and written in the Abstract of Bids, to wit:

WHEREAS, on May 28, 2020, the submitted their Bid Evaluation and Post Qualification Reports citing specific findings on the submitted documents/clarifications by the LCB for each item;

WHEREAS, the Bids and Awards Committee (BAC) certifies that there is "no pending incident" as regard to the result of the post qualification evaluation for this particular project;
