**IB 2020-12 RE-BID (REGULAR)**

**PROCUREMENT OF CALIBRATED HANGING-TYPE WEIGHING SCALE, AND, HEIGHT/LENGTH BOARD**

**RECOMMENDING THE AWARD OF CONTRACT FOR Item No. 1, and, DECLARING FAILURE OF BIDDING for Item No. 2 FOR THE PROCUREMENT CALIBRATED HANGING-TYPE WEIGHING SCALE, AND, HEIGHT/LENGTH BOARD for CY 2020 REQUIREMENTS**

**WHEREAS**, Open Competitive Bidding for the Procurement of Calibrated Hanging-Type Weighing Scale, and, Height/Length Board for CY 2020 requirements was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

**WHEREAS**, on May 27, 2020, the Invitation to Bid (IB) was posted in the PhilGEPS and DOH Website;

**WHEREAS**, a Pre-bidding Conference was held on June 04, 2020 at 10:00 am at DOH-CAR Office Regional Training Center, BGHMC Compound, Baguio City where one (1) prospective bidder, Ms. Mylene Abuel of Philippine First Scales, Inc., attended;

**WHEREAS**, the Submission and Opening of Bids took place as scheduled on June 16, 2020 at 10:00 am at the Regional Training Center, Department of the Health-Center for Health Development-Cordillera Administrative Region (DOH-CHD-CAR) Office, BGHMC Compound, Baguio City;

**WHEREAS**, two (2) prospective bidders procured the bidding documents and submitted their respective proposal, namely:

1. Universal Commercial Corporation
2. First Philippine Scales, Inc.

**WHEREAS**, the first envelopes containing the Eligibility and Technical Documents were opened. The presence, completeness and correctness of the required documents were checked and verified by the designated Bids and Awards Committee (BAC). Upon checking, Universal Commercial Corporation and First Philippine Scales, Inc., were declared “ELIGIBLE” and were rated “PASSED”;

**WHEREAS**, the second envelopes containing the Financial Proposal were opened. The presence, completeness and correctness of the required documents were checked and verified by the BAC. Upon checking, First Philippine Scales, Inc. was declared “NOT COMPLYING” because there was no BAC Form attached to the bid proposal, while, Universal Commercial Corporation was declared “ELIGIBLE”, was rated “PASSED” and subsequently the bid proposal was read publicly and written in the Abstract of Bids, to wit:

WHEREAS, letter dated June 17, 2020 was sent to the Lowest Calculated Bidder (SCB/LCB), Universal Commercial Corporation, requesting to submit post qualification requirements;

WHEREAS, on June 23, 2020, Universal Commercial Corporation submitted their respective additional documentary requirements as part of their technical requirements;

WHEREAS, on June 22, 2020, detailed evaluation of the submitted proposal on the Legal, Technical and Financial aspects of documents on the Single/Lowest Calculated Bidder (SCB/LCB) for the above items was undertaken by the designated Technical Working Group (TWG);

WHEREAS, on July 01, 2020, the TWG submitted their Bid Evaluation and Post Qualification Reports citing specific findings on the submitted documents/clarifications by the LCB for each item;

WHEREAS, the Bids and Awards Committee (BAC) certifies that there is "no pending incident" as regard to the result of the post qualification evaluation for this particular project;

NOW THEREFORE, on the basis of the above, the herein members of the BAC HEREBY RESOLVE, to award the item listed below to the following bidder that was determined to have the Lowest Calculated and Responsive Bid (LCRB):

- 1. Universal Commercial Corporation with a Total Contract Price of One Hundred Ninety-Five Thousand Seven Hundred Fifty Pesos only (₱ 195,750.00) inclusive of local taxes for the item listed below:**
