RECOMMENDING THE AWARD OF CONTRACT FOR Items No. 1, 2, 4 & 5 and DECLARING FAILURE OF BIDDING for Item No. 3 FOR THE PROCUREMENT LABORATORY SUPPLIES (Package V) for CY 2020 REQUIREMENTS

WHEREAS, Open Competitive Bidding for the Procurement of Laboratory Supplies (Package V) for CY 2020 requirements was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

WHEREAS, on August 15, 2020, the Invitation to Bid (IB) was posted in the PhilGEPS;

WHEREAS, a Pre-bidding Conference was held on August 25, 2020 at 10:00 am at DOH-CAR Office Regional Training Center, BGHMC Compound, Baguio City where six (6) prospective bidders attended, namely:

1. Ms. Rose B. Parel – Allied Hospital Supply
2. Mr. JC Balagot – Allied Hospital Supply
3. Ms. Jhessa Deo – Panamed Phils., Inc.
4. Ms. Jerlie Rafael – Phil Pharmawealth Inc.
5. Ms. Desiree V. Gorospe – Steritex Medical System
6. Ms. Evangeline Osalvo – Quinta Medical Healthcare Inc.

WHEREAS, Supplemental Bid Bulletin No. 2020-001 dated August 28, 2020, was issued to modify or amend the technical specifications;

WHEREAS, the Submission and Opening of Bids took place as scheduled on September 07, 2020 at 10:00 am at the Regional Training Center, Department of the Health-Center for Health Development-Cordillera Administrative Region (DOH-CHD-CAR) Office, BGHMC Compound, Baguio City;

WHEREAS, four (4) prospective bidders procured the bidding documents, however, only three (3) submitted their respective proposal, namely:

1. Endure Medical Inc.
2. Northeast Medical Trading
3. Allied Hospital Supply International Corp.

WHEREAS, the first envelopes containing the Eligibility and Technical Documents were opened. The presence, completeness and correctness of the required documents were checked and verified by the designated Bids and Awards Committee (BAC). Upon checking, Northeast Medical Trading was declared “NOT ELIGIBLE” and was rated “FAILED” because the submitted Surety Bond does not have a certificate of authority from the Insurance Commission, while, Endure Medical Inc., and Allied Hospital Supply International Corp. were declared “ELIGIBLE” and were rated “PASSED”;

WHEREAS, the second envelopes containing the Financial Proposal were opened. The presence, completeness and correctness of the required documents were checked and verified by the BAC. Upon checking, Endure Medical Inc. and Allied Hospital Supply International Corp. were declared “ELIGIBLE”, were rated “PASSED” and subsequently the bid proposals were read publicly and written in the Abstract of Bids, to wit:

WHEREAS, on September 8-15, 2020, detailed evaluation of the submitted proposal on the Legal, Technical and Financial aspects of documents on the Single/Lowest Calculated Bidder (SCB/LCB) for the above items was undertaken by the designated Technical Working Group (TWG);

WHEREAS, on September 22, 2020, the TWG presented to the BAC their Bid Evaluation and Post Qualification Reports citing specific findings on the submitted documents/clarifications by the LCB for each item;

WHEREAS, on September 25, 2020, the TWG submitted their Bid Evaluation and Post Qualification Reports citing specific findings on the submitted documents/clarifications by the LCB for each item;

WHEREAS, the Bids and Awards Committee (BAC) certifies that there is “no pending incident” as regard to the result of the post qualification evaluation for this particular project;
