PROCUREMENT OF CATERING SERVICES FOR ACTIVITIES TO BE HELD IN BAGUIO CITY

APPROVING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF CATERING SERVICES FOR ACTIVITIES TO BE HELD IN BAGUIO CITY for CY 2021 REQUIREMENTS

WHEREAS, Open Competitive Bidding for the Procurement of Catering Services for Activities to be held in Baguio City for CY 2021 requirements was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

WHEREAS, on **March 26, 2021**, the Invitation to Bid (IB) was posted in the PhilGEPS and DOH Website;

WHEREAS, a Pre-bidding Conference was held on **April 05, 2021 at 10:00 am** at DOH-CHD-CAR Regional Training Center, BGHMC Compound, Baguio City where no prospective bidder/s attended;

WHEREAS, the Submission and Opening of Bids took place as scheduled on **April 19, 2021 at 10:00 am** at the Regional Training Center, Department of the Health-Center for Health Development-Cordillera Administrative Region, BGHMC Compound;

WHEREAS, one (1) prospective bidder, Gablet's Catering Services, procured the bidding documents and submitted their proposal;

WHEREAS, the first envelope containing the Eligibility and Technical Documents was opened. The presence, completeness and correctness of the required documents was checked and verified by the RBAC in the presence of the prospective bidders' representative. Upon checking, Gablet's Catering Services was declared "ELIGIBLE" and were rated "PASSED";

WHEREAS, the second envelope containing the Financial Proposal was opened. The presence, completeness and correctness of the required documents was checked and verified by the RBAC. Upon checking, Gablet's Catering Services was declared "ELIGIBLE", was rated "PASSED" and subsequently the bid proposal was read publicly and written in the Abstract of Bids, to wit:


