**PROCUREMENT OF INFRASTRUCTURE PROJECT UNDER HEALTH FACILITY ENHANCEMENT PROGRAM (HFEP)**

**RESOLUTION DECLARING THE SINGLE CALCULATED BID AND RECOMMENDING THE SINGLE CALCULATED BIDDER TO UNDERGO POST-QUALIFICATION PROCESS FOR THE PROCUREMENT OF INFRASTRUCTURE PROJECT UNDER HEALTH FACILITY ENHANCEMENT PROGRAM (HFEP): REPAIR AND IMPROVEMENT OF PANOPDOPAN DISTRICT HOSPITAL for CY 2021 REQUIREMENTS**

**WHEREAS**, Open Competitive Bidding for the Procurement of Infrastructure Projects under HFEP: Repair and Improvement of Panopdopan District Hospital for CY 2021 requirements was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

**WHEREAS**, on **June 10, 2021**, the Invitation to Bid (IB) was posted in the PhilGEPS and in the DOH-CHD-CAR Website;

**WHEREAS**, a Pre-bidding Conference was held on **June 17, 2021 at 10:00 am** at DOH-CHD-CAR Office Regional Training Center, BGHMC Compound, Baguio City where one (1) prospective bidder, Sally Belingon of MSMV Construction and Supply, attended;

**WHEREAS**, one (1) bidder, MSMV Construction and Supply, procured the bidding documents;

**WHEREAS**, the Submission and Opening of Bids was scheduled on **June 29, 2021 at 10:00 am** at the Regional Training Center, Department of the Health-Center for Health Development-Cordillera Administrative Region (DOH-CHD-CAR) Office, BGHMC Compound, Baguio City. However, due to lack of quorum of the Bids and Awards Committee, a notice of postponement was issued to reschedule the opening of bids on **July 2, 2021 at 10:00 am**;

**WHEREAS**, MSMV Construction and Supply submitted their respective proposal before the deadline of submission;

**WHEREAS**, Sally Belingon, representative of MSMV Construction and Supply attended the scheduled bid opening;

**WHEREAS**, the first envelope containing the Eligibility and Technical Documents was opened. The presence, completeness and correctness of the required documents were checked and verified by the designated Bids and Awards Committee (BAC). Upon checking, MSMV Construction and Supply was declared "ELIGIBLE" and was rated "PASSED";

**WHEREAS**, the second envelope containing the Financial Proposal was opened. The presence, completeness and correctness of the required documents were checked and verified by the BAC. Upon checking, MSMV Construction and Supply was declared "ELIGIBLE", was rated "PASSED" and subsequently their bid proposal was read publicly and written in the Abstract of Bids, to wit:


