**WHEREAS**, Open Competitive Bidding for the Procurement of Infrastructure Projects under HFEP: Repair and Improvement for CY 2021 requirements was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

**WHEREAS**, attached hereto is BAC Resolution No. 2021-043 which determined the bidder with the Single Calculated Bid (SCB), MSMV Construction and Supply to undergo post qualification process;

**WHEREAS**, on **August 2-4, 2021**, detailed evaluation of the submitted proposal on the Eligibility, Technical and Financial aspects of documents on the bidder with the SCB was undertaken by the designated Technical Working Group (TWG);

**WHEREAS**, on **August 04, 2021**, the TWG submitted their Bid Evaluation and Post Qualification Reports citing specific findings on the submitted documents/clarifications by the SCB;

**WHEREAS**, the Bids and Awards Committee (BAC) certifies that there is "no pending incident" as regard to the result of the post qualification evaluation for this particular project;

**NOW THEREFORE**, on the basis of the above and the Bid Evaluation and Post Qualification Reports of the TWG, the herein members of the BAC HEREBY RESOLVE, to award the projects listed below to the following bidder that was determined to have the Single Calculated and Responsive Bid (SCRB):


