PROCUREMENT OF REPRODUCTION AND PRINTING SERVICES FOR CY 2021 REQUIREMENTS

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO THE BIDDERS WITH THE LOWEST CALCULATED AND RESPONSIVE BIDS for Items No. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 14, 15, 16 & 18, AND DECLARING FAILURE OF BIDDING for Items No. 13 & 17 FOR THE PROCUREMENT OF REPRODUCTION AND PRINTING SERVICES for CY 2021 REQUIREMENTS

WHEREAS, Open Competitive Bidding for the Procurement of Reproduction and Printing Services for CY 2021 requirements was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

WHEREAS, attached hereto is the approved BAC Resolution No. 2021-039 which recommended the following bidders with the Lowest Calculated Bids (LCBs) to undergo post qualification process:

1. EC-TEC Commercial
2. Ideas Associated Solutions
3. Cover and Pages Corp.

WHEREAS, letters dated **July 14, 2021** were sent to the bidders with the LCBs requesting them to submit their post qualification requirements;

WHEREAS, on **July 17-21, 2021**, the bidders with the LCBs submitted their additional documentary requirements as part of their technical requirements;

WHEREAS, on **July 23-27, 2021**, detailed evaluation of the submitted proposal on the Eligibility, Technical and Financial aspects of documents on the LCBs was undertaken by the designated Technical Working Group (TWG);

WHEREAS, on **July 27, 2021**, the TWG submitted their Bid Evaluation and Post Qualification Reports, citing specific findings on the submitted documents/clarifications by the bidder with the LCB;

WHEREAS, the Bids and Awards Committee (BAC) certifies that there is “no pending incident” as regard to the result of the post qualification evaluation for this particular project;

NOW THEREFORE, on the basis of the above and the Bid Evaluation and Post Qualification Reports of the TWG, the herein members of the BAC HEREBY RESOLVE, with the approval of the HoPE to award the items listed below to the following bidders which was determined to have the Lowest Calculated and Responsive Bid (LCRBs):


