Package II - PROCUREMENT OF MEDICAL and DENTAL SUPPLIES

RECOMMENDING THE AWARD OF CONTRACT FOR PACKAGE II specifically Item Nos. 1, 6, 7, 9 & 11, and, DECLARING FAILURE OF BIDDING for Item Nos. 2, 3, 4, 5, 8, 10 & 12 FOR THE PROCUREMENT MEDICAL and DENTAL SUPPLIES for CY 2020 REQUIREMENTS

WHEREAS, Open Competitive Bidding for the Procurement of Medical and Dental Supplies for CY 2020 requirements was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

WHEREAS, on December 05, 2019, the Invitation to Bid (IB) was posted in the PhilGEPS and DOH Website;

WHEREAS, a Pre-bidding Conference was held on December 13, 2019 at 10:00 am at DOH-CAR Office Regional Training Center, BGHMC Compound, Baguio City where six (6) prospective bidders attended, namely:

WHEREAS, Supplemental Bid Bulletin No. 1 dated December 18, 2019, was issued to modify or amend the Invitation to Bid and the technical specifications;

WHEREAS, the Submission and Opening of Bids took place as scheduled on December 27, 2019 at 10:00 am at the Regional Training Center, Department of the Health-Center for Health Development-Cordillera Administrative Region (DOH-CHD-CAR) Office, BGHMC Compound, Baguio City;

WHEREAS, one (1) prospective bidder, Northeast Medical Trading, procured the bidding documents and submitted their respective proposal;

WHEREAS, the first envelope containing the Eligibility and Technical Documents were opened. The presence, completeness and correctness of the required documents was checked and verified by the RBAC in the presence of the prospective bidders' representative. Upon checking, Northeast Medical Trading was declared "ELIGIBLE" and was rated "PASSED";

WHEREAS, the second envelope containing the Financial Proposals were opened. The presence, completeness and correctness of the required documents was checked and verified by the RBAC. Upon checking, Northeast Medical Trading was declared "ELIGIBLE", was rated "PASSED" and subsequently the bid proposals were read publicly and written in the Abstract of Bids, to wit:
