RECOMMENDING THE AWARD OF CONTRACT FOR PACKAGE III specifically Item Nos. 1, 4, 5, 6, 7, 9, 11, 12, 14, 15, 16, 17, 18 & 20, and, DECLARING FAILURE OF BIDDING for Item Nos. 2, 3, 8, 10, 13 & 19 FOR THE PROCUREMENT OF LABORATORY SUPPLIES for CY 2020 REQUIREMENTS

WHEREAS, Open Competitive Bidding for the Procurement of Laboratory Supplies for CY 2020 requirements was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

WHEREAS, on December 05, 2019, the Invitation to Bid (IB) was posted in the PhilGEPS and DOH Website;

WHEREAS, a Pre-bidding Conference was held on December 13, 2019 at 10:00 am at DOH-CAR Office Regional Training Center, BGHMC Compound, Baguio City where six (6) prospective bidders attended, namely:

WHEREAS, Supplemental Bid Bulletin No. 1 dated December 18, 2019, was issued to modify or amend the Invitation to Bid and the technical specifications;

WHEREAS, the Submission and Opening of Bids took place as scheduled on December 27, 2019 at 10:00 am at the Regional Training Center, Department of the Health-Center for Health Development-Cordillera Administrative Region (DOH-CHD-CAR) Office, BGHMC Compound, Baguio City;

WHEREAS, four (4) prospective bidders, procured the bidding documents and submitted their respective proposal, namely:

1. Northeast Medical Trading
2. Jerr Marketing
3. Sterilab Co.
4. Medical Center Trading Corporation

WHEREAS, the first envelopes containing the Eligibility and Technical Documents were opened. The presence, completeness and correctness of the required documents were checked and verified by the RBAC in the presence of the prospective bidders' representative. Upon checking, Northeast Medical Trading, Jerr Marketing, Sterilab Co. and Medical Center Trading Corporation was declared "ELIGIBLE" and was rated "PASSED";

WHEREAS, the second envelopes containing the Financial Proposals were opened. The presence, completeness and correctness of the required documents were checked and verified by the RBAC. Upon checking, Northeast Medical Trading, Jerr Marketing, Sterilab Co. and Medical Center Trading Corporation were declared "ELIGIBLE", were rated "PASSED" and subsequently the bid proposals were read publicly and written in the Abstract of Bids, to wit:

WHEREAS, letters dated December 28, 2019 was sent to the Lowest/Single Calculated Bidder (LCB/SCB), Northeast Medical Trading, Sterilab Co., Jerr Marketing and Medical Center Trading Corp., requesting to submit post qualification requirements;

WHEREAS, on January 6-7, 2020, the bidders stated above submitted their respective additional documentary requirements as part of their technical requirements;

WHEREAS, on January 9-15, 2020, detailed evaluation of the submitted proposal on the Legal, Technical and Financial aspects of documents on the Lowest Calculated Bidders (LCBs) for the above items was undertaken by the designated Technical Working Group (TWG);

WHEREAS, on February 3, 2020, the TWG presented to the BAC and submitted their Bid Evaluation and Post Qualification Reports citing specific findings on the submitted documents/clarifications by the LCB for each item;

WHEREAS, a side-by-side evaluation of item number 20: *“Ziehl Neelsen/Acid Fast Bacilli (AFB) Staining kit, bottle of 500 ml Carbon Fuchsin, 2 bottles of 500 ml Acid Alcohol and 1 bottle of 500 ml Methylene Blue, (Hot/Cold Method) with dripper/pipette”* was done by the three (3) facilities in Baguio City namely: Baguio General Hospital and Medical Center (BGHMC, Saint Louis University-Hospital of the Sacred Heart (SLU-HSH) and Baguio City Health Services Office (BCHSO). This is to comply with the specifications of the said item.

WHEREAS, on March 13, 2020, a detailed side-by-side evaluation report of the Acid Fast Bacilli (AFB) Stain was submitted by the TWG and recommends the award of the said item to Medical Center Trading Corporation for having the highest rating from which indicates the higher quality. The said report is on file with the BAC Secretariat.

WHEREAS, the Bids and Awards Committee (BAC) certifies that there is “no pending incident” as regard to the result of the post qualification evaluation for this particular project;


