**PROCUREMENT OF CATERING SERVICES**

**APPROVING THE AWARD OF CONTRACT FOR PACKAGE I-BAGUIO CITY & PACKAGE V-IFUGAO PROVINCE, and, DECLARING FAILURE OF BIDDING FOR PACKAGE II, III, IV, VI and VII FOR THE PROCUREMENT OF CATERING SERVICES for CY 2020 REQUIREMENTS**

**WHEREAS**, Open Competitive Bidding for the Procurement of Catering Services for CY 2020 requirements was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

**WHEREAS**, on March 05, 2020, the Invitation to Bid (IB) was posted in the PhilGEPS and DOH Website;

**WHEREAS**, a Pre-bidding Conference was held on March 13, 2020 at 10:00 am at DOH-CHD-CAR Regional Training Center, BGHMC Compound, Baguio City where five (5) prospective bidders attended, namely:

1. Ms. Gemma Calimlim – GEM’S Catering Services and Refreshments
2. Ms. Zonia Lapaan – Thickface Food Services
3. Ms. Alpha May Mumog – Travelite Hotel/Newtown Plaza Hotel Corp.
4. Ms. Daisy Olowan – JD’s Catering Services
5. Ms. Marlyn Landingin – Gablets Catering Services

**WHEREAS**, Supplemental Bid Bulletin No. 1 dated March 18, 2020, was issued to modify or amend the technical specifications;

**WHEREAS**, the Submission and Opening of Bids took place as scheduled on March 25, 2020 at 1:30 pm at the Regional Training Center, Department of the Health-Center for Health Development-Cordillera Administrative Region, BGHMC Compound;

**WHEREAS**, two (2) prospective bidders procured the bidding documents and submitted their respective proposals, namely:

1. Gablet’s Catering Services – Package I (Baguio City)
2. Gem’s Catering Services and Refreshments – Package V (Ifugao Province)

**WHEREAS**, no prospective bidder/s procured the bidding documents for Package II-Abra Province, Package III-Apayao Province, Package IV-Benguet Province, Package VI-Kalinga Province and Package VII-Mountain Province. Hence, no bidding proposal/s submitted;

**WHEREAS**, the first envelopes containing the Eligibility and Technical Documents were opened. The presence, completeness and correctness of the required documents were checked and verified by the RBAC in the presence of the prospective bidders’ representative. Upon checking, Gablet’s Catering Services and Gem’s Catering Services were declared “ELIGIBLE” and were rated “PASSED”;

**WHEREAS**, the second envelopes containing the Financial Proposals were opened. The presence, completeness and correctness of the required documents were checked and verified by the RBAC. Upon checking, Gablet’s Catering Services and Gem’s Catering Services were declared “ELIGIBLE”, were rated “PASSED” and subsequently the bid proposals were read publicly and written in the Abstract of Bids, to wit:

**WHEREAS**, the Bids and Awards Committee (BAC) certifies that there is “no pending incident” as regard to the result of the post qualification evaluation for this particular project;


